BY-LAW AMENDMENTS–

WORKMEN'S COMPENSATION –

IF YOU ARE INJURED ON THE JOB CONTACT YOUR UNION REPRESENTATIVES TO RECEIVE IMPORTANT LEGAL INFORMATION THAT WILL HELP YOU RETAIN THE NECESSARY BENEFITS.

UN-SAFE VEHICLES –

IF YOU ARE DRIVING AN UNSAFE VEHICLE AND YOU ARE IN AN ACCIDENT YOU ARE RESPONSIBLE. DO NOT TAKE THE CHANCE WRITE THE VEHICLE UP AND REFUSE TO DRIVE THE VEHICLE.

CHARTERS –

ARBITRATION VOTE –

THERE SHALL BE AN ARBITRATION VOTE AT THE NOVEMBER 5, 2008 MEETING OF THE MEMBERSHIP FOR BARGAINING UNIT MEMBER WILLIAM EHMAN. BILL'S GRIEVANCE IS CURRENTLY IN THE FORTH STEP OF THE GRIEVANCE PROCEDURE WHICH IS ARBITRATION.

AN OVERVIEW OF THE GRIEVANCE WILL BE PROVIDED TO THE MEMBERSHIP BY THE EXECUTIVE BOARD THEN BILL WILL ADDRESS THE MEMBERSHIP WITH HIS GRIEVANCE. A QUESTION AND ANSWER SESSION WILL TAKE PLACE THEN A VOTE OF THE MEMBERSHIP THAT IS PRESENT AT THE MEETING.

IF THE MEMBERSHIP VOTES IN FAVOR OF THE GRIEVANCE THEN THE COST OF THE ARBITRATION WILL BE SHARED BY THE ENTIRE BARGAINING UNIT AT ALL FACILITIES. IF THE MEMBERSHIP VOTE IS AGAINST THE GRIEVANCE THE UNION WILL WITH DRAW FROM THE PROCEDURE.
